1. Workshop: Identify, Address, Solve – sustainable solutions to pressing chemical and waste threats

In this workshop, we will discuss rising global chemicals and waste issues and develop strategies and identify what needs should urgently be addressed.

Moderator: Susan Haffmans (PAN Germany) & Janna Kuhlmann (BUND)

Chemical production will increase in the future and with it the negative impacts on human health, biodiversity loss and the environment. Already now we face multiple urgent problems caused by chemicals for which we need international solutions, among those are forever chemicals, plastics, highly hazardous pesticides, endocrine disrupting chemicals or heavy metals. As long as binding conventions are lacking, a sustainable international chemical and waste management must find and initiate solutions - very quickly. Finally, we need to address increasing chemical use and production and pave the way towards a sustainable transformation that includes non-chemicals alternatives.

SAICM works on specific Emerging Policy Issues and Issues of Concern which have not delivered up to the expectations. The problems are still not resolved, and new ones emerge on a daily basis. What are the urgent issues and problems for which international solutions are needed? What can be done without legally binding agreements? What is the role of the future international chemicals and waste management, and can it initiate solutions? What is our role as civil society in initiating new issues?



2. Workshop: Raise political commitment – the Bonn High level Declaration on track

In this Workshop we work on the requirements and needs of the new High Level Declaration (HLD).

At the high-level segment of the World Chemicals Conference (28.-29.9.23), governments will agree on a new high-level declaration. This new Bonn Declaration will replace the current "<u>Dubai Declaration</u>", the current founding document of SAICM. It will serve to mobilize political commitment and resources and will be an important part of the future sound management of chemicals and waste. The declaration will be drafted during the first days of ICCM5 by a working group based on earlier drafts. Together we want to make clear how important such a declaration is and also discuss the requirements for such a high-level declaration from a civil society perspective. Together with our different perspectives, knowledge and background, we will identify multiple requirements that we will bring to the working group.

3. Workshop: Strengthening multi-sectoral engagement – Moving towards a strong and global collaboration on chemicals and waste management

With this Workshop, we want to share experiences and discuss best practices on how to collaborate with new partners.

Moderator: Giulia Carlini (CIEL) & Florian Schulze (EnvMed)

Chemicals are part of our daily life and industrial processes. But we urgently need to phase out the most hazardous chemicals and use more sustainable alternatives, including non-chemical alternatives. This is a big task and can only be successful if the chemicals and waste management is not only recognized as an environmental issue. SAICM has improved collaboration between the health, labor and environmental sector, but there might still crucial actors missing. There are important actors who are interested, but for them, we need easy access to the process and onboarding activities. For example, the Youth Group is still quite new to the process and brings in important aspects according to age and an intergenerational perspective. A Gender and Chemicals Group is an important actor to address the different exposure by gender. The goal of the workshop is to discuss best practices for meaningful and successful collaboration with actors outside the NGO world. What do different actors need to enhance their engagement? Where do participants of the workshop see ways to improve cooperation, what can they contribute?
